



2020-2021 RATE AND SCHEDULE INFORMATION

Operational Hours: 7:30 AM – 5:30 PM. Year-Round. The Spotted Zebra Learning Center is closed the week between Christmas and New Year's and the week prior to Labor Day.

Registration: A non-refundable registration fee of \$75.00 per family is due at the time of enrollment.

Weekly Rate: The weekly rate is as follows:

- \$245/week for full-day (7:30 – 5:30), 5 days a week
- \$170/week for full-day (7:30 – 5:30), 3 days a week
- \$120/week for full-day (7:30 – 5:30), 2 days a week
- \$195/week for half-day (8:30 – 1:30), 5 days a week
- \$130/week for half-day (8:30 – 1:30), 3 days a week
- \$95/week for half-day (8:30 – 1:30), 2 days a week
- \$125/week for part-time (8:30-11:00), 5 days a week, 3 year-olds only

The Spotted Zebra Learning Center charges tuition 50 weeks a year, regardless of holidays. It does not charge for the two weeks it closes during the year. Tuition payments are due by the close of the business day each Friday for the current week's care. Tuition is **only accepted** with Tuition Express, an automatic withdrawal from a checking or savings account.

Sibling Discount: A 10% discount will be available to families that enroll more than one child on a ***full-time basis***.

Insufficient Fee Charge: There will be a \$20 charge if a payment is returned for insufficient funds in the owner's account. If a parent falls more than a week behind in tuition payment, the child will not be allowed to attend the Center's Wrap Around program until payment is brought up to date.

Late Pick Up: The fee of \$10 for every 10 minutes will be charged for any child remaining at the center after 5:30 PM.

Discontinued Enrollment: Parents may withdraw their child from the preschool by giving written notice of intent to withdraw at least 14 calendar days before the child is withdrawn. Charges will cease at the end of the 14th day.

COVID-19: Should the Spotted Zebra Learning Center be forced to close for a period **greater** than ten (10) consecutive school days due to COVID-19, weekly tuition charges will stop after the tenth (10) school day until the Center re-opens. At the point of re-opening, tuition will resume.
